Maintain maximum protection under warranty by ensuring your motorcycle is serviced in accordance with the recommendations of the scheduled maintenance chart(s) in the owner's manual.

The appropriate service record must be stamped by your authorized Cleveland CycleWerks dealer or service center.

Whenever service, repair and/or warranty work is performed, this book must be made available to your Cleveland CycleWerks dealer and/or service center.

If you should sell your motorcycle, ensure that this book, together with other relevant documents are passed to the new owner.

Within the warranty period, Cleveland CycleWerks Authorized Distributor, warrants your new motorcycle detailed on page 3, to be free from any defects in materials used in the manufacture, and/or workmanship at the time of its manufacture.

Any part found to be defective during this period will be repaired or replaced at the discretion of our authorized distributor, by an authorized Cleveland CycleWerks dealer.

Any part replaced under the warranty will be covered for the remaining period of the warranty.

Any parts replaced under warranty must be returned to Cleveland CycleWerks Authorized Distributor and will become the property of Cleveland CycleWerks Authorized Distributor in your country.

Cleveland CycleWerks Authorized Distributor may, at its discretion make any repairs or replacement of defective parts failing outside the warranty, but such work shall not be deemed to be any admission of liability.

The warranty may be transferred to subsequent owners for the balance of the remaining period.

Cleveland CycleWerks is not implying, entering into, or extending a warranty directly. All warranties are extended strictly by our Authorized Distributor in your country.

This service handbook should be considered a permanent part of the motorcycle and should remain with the vehicle if it is resold.

CONSUMER INFORMATION FOR UNITED STATES

Tampering with noise & emissions control systems is prohibited

Owners are warned that the law prohibits:

- A.** The removal or rendering inoperative by any person other than for purposes of maintenance, repair or replacement, of any device or element of design incorporated into any new vehicle for the purpose of noise and/or emissions control prior to its sale or delivery to the ultimate purchaser or while it is in use; and
- B.** The use of the vehicle after such device or element of design has been removed or rendered inoperative by any person.

Cleveland CycleWerks reserves the right to modify any equipment, technical specifications, colors, materials, services offered and rendered, to adapt them to local business practices, as we deem necessary. If more information is needed, please ask your local Cleveland CycleWerks dealer for information.

MANUFACTURER DIRECTED MAINTENANCE

The California Air Resources Board, the U.S. Environmental Protection Agency, Cleveland CycleWerks LLC., and our authorized distributor (hereinafter "Distributor") are pleased to explain the emission control system warranty on your Motorcycle and off road vehicle (dirt bike). New motor vehicles must be designed, built and equipped to meet U.S. EPA Federal, California Anti Smog and California ARB Standards. Distributor must warrant the emission control system on your vehicle for 30 months or 5,000 km, whichever comes first, provided that there has been no abuse, neglect or improper maintenance of your vehicle. They meet or exceed the minimum requirements of such tests, and on the basis of such tests, they conform and exceed the requirements of the regulations in this part (Ref: 40CFR§86 and 40CFR1051.) Off-Road vehicles such as these are covered in Part1051.

Your emission control system may include parts such as the carburetor or fuel injection system, the ignition system, catalytic converter and engine computer, if it is equipped. Also included may be hoses, belts, connectors and other emission-related assemblies.

Where a warrantable condition exists, Distributor will repair your vehicle at no cost to you, including diagnosis, parts and labor.

If an emission-related part on your vehicle is defective, the part will be repaired or replaced by Distributor. This is your emission control system DEFECTS WARRANTY.

NOTICE! Use of any Cleveland CycleWerks brand vehicle in any type of competitive event completely and absolutely voids this and all other warranties offered by Cleveland CycleWerks Authorized Distributor.

OWNER'S WARRANTY RESPONSIBILITY

As the motorcycle owner, you are responsible for the performance of the required maintenance listed in your owner's manual.

Cleveland CycleWerks recommends that you retain all receipts covering maintenance on your motorcycle, but Cleveland CycleWerks Authorized Distributor cannot deny warranty solely for the lack of receipts or for your failure to ensure the performance of all scheduled maintenance.

You are responsible for presenting your motorcycle to a Cleveland CycleWerks dealer as soon as a problem exists. The warranty repairs should be completed in a reasonable amount of time, not to exceed 30 days.

As the motorcycle owner, you should also be aware that Cleveland CycleWerks Authorized Distributor, may deny you warranty coverage if your motorcycle or a part has failed due to abuse, neglect, improper maintenance or unapproved modifications.

If you have any questions regarding your warranty right and responsibilities, you should contact Cleveland CycleWerks or Cleveland CycleWerks authorized Distributor, email Sales@ClevelandCycleWerks.com, or call, 1(856)438-6561, or (for California registered off-road vehicles only) the California Air Resources Board at P.O. Box 8001, 9528 Telstar Avenue, El Monte, CA. 91731-8001. Cleveland CycleWerks Authorized Distributor warrants that each new 2016 and later Cleveland CycleWerks brand on road and off road vehicle:

- A. is designed, built and equipped so as to conform at the time of initial retail purchase with all applicable regulations of the United States Environmental Protection Agency, and the California Air Resources Board; and
- B. is free from defects in material and workmanship which cause such vehicle to fail to conform to applicable regulations of the United States Environmental Protection Agency or the California Air Resources Board for the periods specified above.
- C. **Coverage:** Warranty defects shall be remedied during customary business hours at any authorized Cleveland CycleWerks dealer and/or service center located within the United States Environmental Protection Agency and the California Air Resources Board. Any part or parts replaced under this warranty shall become the property of Cleveland CycleWerks Authorized Distributor.

D. **Limitations.** This Emission Control System Warranty shall not cover any of the following:

- A. Repair or replacement as a result of
 - 1. Accident(s)
 - 2. Misuse
 - 3. Repairs improperly performed or replacement parts improperly installed
 - 4. Use of replacement parts or accessories which are not genuine Cleveland CycleWerks replacement parts which adversely affect performance and/or
 - 5. Use in competitive racing or related events.
- B. Inspections, replacement of parts and other services and adjustments required for required maintenance.
- C. Any vehicle equipped with an odometer or hour meter on which the odometer mileage or hour meter reading has been changed so that the actual mileage cannot be readily determined.

E. **Limited Liability**

- A. The liability of Cleveland CycleWerks Authorized Distributor, under this Emission Control System Warranty is limited solely to the remedying of defects in material or workmanship by an authorized Cleveland CycleWerks dealer at its place of business during customary business hours. This warranty does not cover inconvenience or loss of use of the vehicle or transportation of the vehicle to or from the Cleveland CycleWerks dealer. CLEVELAND CYCLEWERKS AUTHORIZED DISTRIBUTOR SHALL NOT BE LIABLE FOR ANY OTHER EXPENSES, LOSS OR DAMAGE, WHETHER DIRECT, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY ARISING IN CONNECTION WITH THE SALE OR USE OF OR INABILITY TO USE THE CLEVELAND CYCLEWERKS VEHICLE FOR ANY PURPOSE. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.
- B. NO EXPRESS EMISSION CONTROL SYSTEM WARRANTY IS GIVEN BY CLEVELAND CYCLEWERKS AUTHORIZED DISTRIBUTOR, EXCEPT AS SPECIFICALLY SET FORTH HEREIN. ANY EMISSION CONTROL SYSTEM WARRANTY IMPLIED BY LAW, INCLUDING ANY WARRANTY OF MECHANABILITY OR FITNESS FOR A PARTICULAR PURPOSE, IS LIMITED TO THE EXPRESS EMISSION CONTROL SYSTEM WARRANTY TERMS STATED IN THIS WARRANTY. THE FOREGOING STATEMENTS OF WARRANTY ARE EXCLUSIVE AND IN LIEU OF ALL OTHER REMEDIES. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.
- C. **No dealer is authorized to modify this Cleveland CycleWerks Authorized Distributor Limited Emission Control System Warranty.**

F. **LEGAL RIGHTS.** THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

G. THIS WARRANT IS IN ADDITION TO THE CLEVELAND CYCLEWERKS AUTHORIZED DISTRIBUTOR LIMITED OFF ROAD VEHICLE WARRANTY.

H. **ADDITIONAL INFORMATION.** Any replacement part that is equivalent in performance and durability may be used in the performance of any maintenance or repairs. However, Cleveland CycleWerks Authorized Distributor is not liable for these parts. The owner is responsible for the performance of all required maintenance. Such maintenance may be performed at a service establishment or by any individual. The warranty period begins in the date the motorcycle is delivered to an ultimate purchaser.

MANUFACTURER DIRECTED MAINTENANCE

As a responsible manufacturer, Cleveland CycleWerks under the direction and implementation of our Authorized Distributor, occasionally requests your servicing dealer that your motorcycle undergo items of maintenance in addition to those specified in the routine maintenance schedule. These additional maintenance items should be recorded by your dealer in the table below.

NOISE CONTROL SYSTEM WARRANTY

The following warranty applies to the noise control system and is in addition to the general Cleveland CycleWerks Authorized Distributor warranty and the emission control warranty.

Cleveland CycleWerks Authorized Distributor warrants to the first, and each subsequent owner, that the vehicle was designed and built so as to conform, at the time of sale, with the regulations and, at the time of manufacture, was free from defects in materials and workmanship which would cause the motorcycle not to meet the noise control system warranty extends for a period of six (6) calendar months starting from the date of purchase. Same warranty applies to a demonstration motorcycle or company motorcycle.

WE RECOMMEND THAT ONLY FACTORY GENUINE CLEVELAND CYCLEWERKS PARTS BE USED FOR MAINTENANCE REPAIR OR REPLACEMENT OF THE NOISE CONTROL SYSTEM.

If Non-Factory Genuine Parts are used to repair your motorcycle, warranty claims may be denied.

**NOTICE**

This motorcycle should be checked for repair or replacement if the motorcycle noise has increased significantly through use, otherwise the owner may become subject to penalties under state and local laws

TAMPERING WITH NOISE CONTROL SYSTEM

Owners are warned that the law prohibits:

- (A) The removal or rendering inoperative by any person other than for purposes of maintenance, repair or replacement, of any device or element of design incorporated into any new vehicle for the purpose of noise control prior to its sale or delivery to the ultimate purchaser or while it is in use;
- (B) The use of the vehicle after such device or element of design has been removed or rendered inoperative by any person.

Acts which are likely to constitute tampering include the following;

1. Removal or tampering with the muffler's, baffles or header pipes or any other component, which conducts exhaust gases.
2. Removal of or puncturing of any part of the air intake system.
3. Failure to carry out maintenance as prescribed in the owner's manual.
4. Replacing any part of the exhaust or air intake system with parts other than those specified by Cleveland CycleWerks.

The following items are not covered by the noise control system warranty;

1. Failures, which arise through misuse, alterations or accident damage.
2. Replacing, removing or modifications of any part of the noise control system (consisting of the exhaust system and air intake system) with parts not certified to be noise legal for street use.
3. Cleveland CycleWerks Authorized Distributor shall not be liable for loss of use, inconvenience, lost time, commercial losses or other incidental or consequential damages.

SERVICE RECORD

The following pages are used to record services carried out by your authorized Cleveland CycleWerks dealer. You can ride confident, with the knowledge that your machine is being serviced to the high standards demanded by Cleveland CycleWerks and a Cleveland CycleWerks Authorized Distributor. Proof that your motorcycle has been serviced to these standards will be a useful aid if you decide to sell your motorcycle.

Your motorcycle may require more frequent servicing if operated in severe climates or conditions, or if it is used for short, stop-start trips. Further information may be obtained from your authorized Cleveland CycleWerks dealer.

CARING FOR YOUR MOTORCYCLE

Cleveland CycleWerks has taken great care in the selection of materials, plating and painting techniques so as to provide its customers with a quality cosmetic appearance allied with durability. However, motorcycle are often used in hostile environmental conditions and in these circumstances, it is essential that the motorcycle is washed, dried and lost lubricity replaced to prevent discoloration particularly of plated, un-plated, unpainted metallic surfaces. Your dealer can provide further information and advice if required. Ultimately the appearance of your machine will very much depend on the care it receives.
